START-UP COMPANIES CAN NOW BENEFIT FROM THE R&D TAX CREDIT

If you're a start-up company with annual gross receipts of less than \$5 million, you can now apply up to \$250,000 of your R&D credit against your payroll tax liability.



The federal R&D tax credit is a dollar-for-dollar reduction of federal income tax liability for

qualified expenditures incident to the development or improvement of a product, process, software, formula or invention. It was recently made permanent by The Protecting Americans from Tax Hikes Act of 2015 ("PATH" Act).
