The United States
Supreme Court
announced on January
12, that it has granted
certiorari and will hear a
case related to state
taxes - something that
does not happen often!
The High Court could



finally settle an ongoing battle between e-retailers and states about how online purchases are taxed, and in the process may overturn a 1992 ruling which currently prevents states from collecting sales taxes on online purchases unless the seller has a physical presence in the state. An overhaul of this nature would change the state tax landscape significantly and require more online sellers to collect sales tax.
