

In the United States, the sales tax landscape has changed drastically due to the U.S. Supreme Court Case of South Dakota v. Wayfair (June 2018). Following this landmark decision which made it easier for companies to create nexus in states, many states have enacted legislation which establishes guidelines/thresholds for economic nexus.
