HAPPY ANNIVERSARY WAYFAIR!

It's been just over a year since the U.S. Supreme Court handed down its landmark decision in <u>South Dakota v. Wayfair Inc.</u> on 6/21/18. This key ruling paved the way for states to enact economic nexus legislation and thereby more easily require companies to collect, remit and report sales tax. This decision quickly changed the sales tax world in a big way, particularly for on-line retailers, but also for many other companies.

WHAT COMPANIES NEED TO KNOW ABOUT VOLUNTARY DISCLOSURE AGREEMENTS

The phrase of the day is "V-D-A"! In the state tax world, that refers to Voluntary Disclosure Agreements, and we are working on many of



these for our clients lately. What are they, exactly, and why should your company perhaps be considering them as well?

What is a Voluntary Disclosure Agreement?

Simply put, entering into voluntary disclosure agreements with states is about companies identifying their potential state tax exposure (sales tax, income tax, or both) and coming forward voluntarily to pay any outstanding liabilities before the state identifies the company as part of an audit or other outreach effort. As states are becoming more aggressive in their pursuit of out-of-state taxpayers, it's becoming a bit of a game of "Beat the Clock!"
