

WHAT YOU NEED TO KNOW: STATES' ONLINE SALES TAX & MARKETPLACE FACILITATORS

Across the country, states continue to update their sales tax laws in an effort to clarify provisions and increase state income. Of course, because company sales extend beyond state borders, it's extremely important for your business to be aware of various multi-state tax issues and how they may affect your organization.

One major trend we're seeing (unsurprisingly) is more states' adoption of economic nexus and online sales tax provisions based on the *Wayfair* Supreme Court case. In

addition, states that had adopted marketplace facilitators as part of their tax code are beginning to clarify their new role. What does this mean? Keep reading for the details!

FOCUS ON OREGON

Oregon, also known as the Beaver state, is located in the Pacific Northwest region of the West coast of the United States. The Columbia River delineates much of Oregon's northern boundary with



Washington, while the Snake River delineates much of its eastern boundary with Idaho. Oregon is one of only three states of the contiguous United States to have a coastline on the Pacific Ocean.

Oregon is one of the most geographically diverse states in the U.S., marked by volcanoes, abundant bodies of water, dense evergreen and mixed forests, as well as high deserts and semi-arid shrublands. At 11,249 feet, Mount Hood, a volcano, is the state's highest point. Oregon's only national Park, Crater Lake National Park, comprises the caldera surrounding Crater Lake, the deepest lake in the United States. The state is also home to the single largest organism in the world Armillaria ostoyae, a fungus that runs beneath 2,200 acres of the Malheur National Forest.
