

MARYLAND JUMPS ABOARD THE BANDWAGON TO TAX SAAS AND DIGITAL PRODUCTS

Maryland has enacted House Bill (HB) 932 that will subject Digital Products such as ebooks, songs and movies along with electronically delivered software, including Software as a Service ("SaaS") to sales and use taxation. The legislation becomes effective on March 14, 2021.

HOW STATES HAVE BENEFITED FROM THE WAYFAIR DECISION

Over the last several years, the U.S. Supreme Court's decision in <u>South</u> <u>Dakota v. Wayfair</u> has led to rule changes regarding



online sales tax in almost every state in the country. The ruling, that South Dakota's economic nexus law was constitutional and that the state could require companies who met certain sales thresholds to collect and remit sales tax on sales to South Dakota customers, even if the company had no physical presence, has impacted states, retailers, online marketplaces and even brickand-mortar businesses.
