

If there weren't a special exemption, online retailers would need to pay sales tax on the wholesale items, only to turn around and have their customers pay it again when they buy their products, resulting in double taxation. This is where resale certificates come in.

It has been almost a year since the U.S. Supreme Court handed down its landmark decision in <u>South Dakota</u> <u>v. Wayfair Inc.</u> (June 2018) , making it easier for states across the



country to enact nexus triggering legislation, and ultimately leading to the collection of sales tax from companies doing business in various states.


