

NEW CALIFORNIA COMPETES GRANT PROGRAM

Since 2013, when California eliminated its statewide enterprise zone tax credit and incentive programs, we have been following the evolution of



the <u>California Competes Tax Credit ("CCTC")</u> program, which seeks to award tax credits to companies locating to or expanding within California. The program has had its issues, certainly. Not the least of which is that few companies have been able to take advantage of the program, either because they do not engage in the type of expansion necessary, or because they are not paying income tax due to excess net operating losses, tax credits (i.e.; Research and Development Credits) or other reasons.
