

Since the Supreme Court's decision in [South Dakota v. Wayfair Inc.](#) in June 2018, we've been helping clients to make sense of this somewhat confusing concept.

While physical presence nexus (employees, inventory, office space) in a state is also still in play and creates a filing requirement, companies find themselves tripping into nexus much more quickly now because of the sales and transaction thresholds of economic nexus legislation, which varies from state to state.

Understanding [sales tax compliance for SaaS companies](#) is difficult. Some states tax it, some don't. But what about cities?



## FOCUS ON SOUTH CAROLINA

South Carolina is a state in the Southeastern United States and the easternmost state of the Deep South. The state can be divided into three geographic areas. From east to west: the Atlantic coastal plain, the Piedmont, and the Blue



Ridge Mountains. Locally, the coastal plain is referred to as the Low Country, and the other two regions as the Midlands and the Upstate respectively. The Atlantic coastal plain makes up two-thirds of the state. Its eastern border is the Sea Islands, a chain of tidal and barrier islands.

The state has a humid subtropical climate, although high elevation areas in the upstate area have few subtropical characteristics than areas on the Atlantic coastline. In the summer, South Carolina is hot and humid. Winter temperatures are much less uniform in South Carolina. Snowfall is somewhat uncommon in most of the state, while coastal areas receive less than an inch annually on average.
